NARRATIVE

On June 18th, 2022 I opened an investigation in reference to Enid Librarian Theri Ray starting a discord chat with minor children that discussed possible sexual content. Prior to speaking with Theri, I was advised that the discord group that Theri created was being ran as a City of Enid Public Library event. I also learned that this was discussed during a meeting that was held by the Enid Public Library Board. Due to this meeting being recorded, I watched the meeting to see what was discussed. I observed during the meeting that when the discord group was created it was discussed that the parents should not know about it. During the meeting Theri was asked if they were discussing sexual content within the chat, and her response was that the content discussed was in reference to the definitions pertaining to LGTBQ+.

Theri Ray:

On the same date listed above, I called and spoke to Theri via telephone. During the conversation with Theri, she asked if I could come to the Enid Public Library and she would show me the discord content. I advised Theri that I could and would be there shortly. After a period of time, I called Theri back and asked if she would be willing to just give me the account login and password. I told her that it would be easier for me to sort through the content and be more efficient. Theri stated that would be fine and advised she would respond to the Police Department when she left work. When she arrived I escorted Theri to my office located in the investigations division. I informed Theri that she was in no way obligated to allow me into the account with a warrant, and Theri stated she had no issues with allowing me into the account. Theri logged me into the account and she left the Police Department.

Review of Discord Account:

When I first opened the account, I observed that the discord profile was created under Theri's City of Enid work email. I also observed there to be several different groups that were labeled at "teen" type groups. After watching the meeting as listed above, I located the "#teen-homosapiens" group and went through that group first.

I scrolled to the beginning of the chat and saw that the group was created on June 8th, 2021 and it appears that the group was created by "LibraryTheri" who was the first person to comment in the group with "Welcome." From what I could see by first looking at all who were in the group, it appears there were only fourteen members that were included in the group. While looking at the members, I could see that "Librarian Rowan and Library Theri" were the group administrators. The

other members I cannot identify. Other than "Margo the Librarian and MeganTheeLibrarian." I scrolled through this chat thread and did not find anything that would be criminal in nature. However, based off the concerns from the recorded meeting I watched, below will be a few things that I observed in the thread.

LibraryTheri posted on June 9th, 2021 that she made the channel private but she did state to feel free to invite anyone who would appreciate the conversation. On August 19th, 2021 Library Rowan introduced to the group as a pansexual trans woman and his preferred pronouns are they/them and identified himself as one of the librarians. He added that Dungeons & Dragons has a reputation of being catered toward cishet white men and generally unwelcoming to LGBTQIAP+ and POC. He continued by adding that he would be running a Dungeons and Dragons. He stated that he would like to specifically like to invite anyone in this particular group to join. He then went to add the dates of when it would be played. However, I cannot speak to Dungeons and Dragons as I do know have knowledge of how this game is ran.

Emma went on to post on November 1st, 2021 to introduce as one of the librarians and stated "I'm a nonbinary lesbian and added pronouns as they/them. Emma added she is the substitute homosapiens meeting manager and added when the next meeting would be held. She stated the voice chat for the channel would only be visible to the people in this particular group.

On March 10th, 2022 Emma posted that the new book was set out on the book club table. Emma advised when the next meeting would be and posted a picture of the new book with a sign located next to the book. From what I can see, it looks like this book was offered for the members of this private group chat as it was listed as the "homosapiens united" book. Emma went on later to advise of a content warning stating the major subplot for the book was about an older adult preying on one of the teen characters. Emma went on to say that she was advising in case it was something the people reading needing to treed lightly around. Emma stated this book would be discussed at the April meeting.

There were obviously other threads within in this group, but it appeared to be general discussion. Also, It should be noted that I was a part of this group and cannot speak to any of the context that the discussion was about. I only noted this text as it was part of the discussion that occurred during the board meeting that was listed at the beginning of this report.

The next chat room that I went to observe was the #teen-anime-manga chat. This chat appeared to have started on January 28th, 2021. At the welcome screen of the chat it stated "This is the start of the #teen-anime-manga channel. This channel is for the discussion of amine/manga. This is teen centered, teen appropriate, and teen safe." It appears that LibraryTheri is the administrator of the group and possibly sixty people in the group.

On February 18th, 2021 Theri posted about "Death Note." LibrarianLee posted that she enjoyed it and that it was pretty popular. Theri posts that there is discussion about if it is a teen series. Theri states that it is listed as "great graphic novels for teens" but some publishers list it as adult. LibrarianLee states she knows plenty of teens who have read it. posts that it would be ok to show for anime club but it has a lot of death and the "shinigami" can look a little freaky. LibrarianLee posts that you may want to make it public what your possible viewing options are in advance so that parents area aware. She later states she would refer back to making a viewing list publicly available to avoid parental complaints down the line. Librarian Rowan posts that there are

mentions/hints/implications toward sexual assault, on screen shootings, suicide, and "torture." Rowan goes on to state it's not like beating someone but it is still someone held in captivity while blindfolded and restrained for an extended period of time. Rowan posted a photo of the rating which states "Teen Plus- May be suitable for older teens and adults. For example, may contain intense and/or gory violence, sexual content, frequent strong language, alcohol, tobacco and/or other substance abuse."

This group chat ended on April 25th, 2022. There were obviously other threads within in this group, but it appeared to be general discussion. Also, it should be noted that I was a part of this group and cannot speak to any of the context that the discussion was about. I only noted this text as it was part of the discussion that occurred during the board meeting that was listed at the beginning of this report.

The next chat room I observed was the #teen-general chat. This chat appeared to have started on January 28th, 2021. At the welcome screen of the chat it stated "This is the start of the #teen-general channel. This channel is for general teen related discussions. There appears to be LibraryTheri as the administrator and sixty people in the chat.

While scrolling through the messages I came to the date of December 15th, 2021. It appears there are messages that were deleted due to Librarian Rowan stating "this is not a request as a mod but as an individual, but can we not with this conversation, at least outside of (consensual, ask permission first) DMs." I am unsure as to what this conversation was about, but another individual then asks to stop. Then on April 25th, 2022 someone asks who keeps sending those things. This was followed up by Emma stating "please don't send pornography in the library group chat:) read the #code-of-conduct." Due to this being a "teen" based chat room, this could have resulted in someone under the age of eighteen to have been subjected to pornographic material which could have resulted in a violation of state law. However, due to the material being removed I do not know what the material was or if it was actual pornographic in nature.

On July 2nd, 2022 it was discussed by the Library personnel that people have been getting hacked within the group and to tread carefully around any DM requests. Due to this, it appears to me
