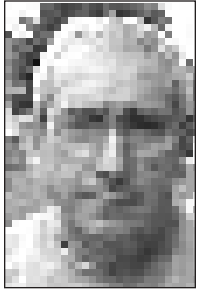


ELECTION 2002: CITY RACES

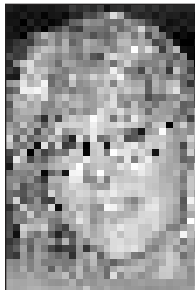

ANTRIM COUNTY

MILTON TOWNSHIP Proposal A — Definition of family

Shall the following amendment to the Milton Township Zoning Ordinance be approved? The new definition of "family" in Part 117.103 - Definitions, Sec. 1.03, of Amendment #2001-2 to the Milton Township Zoning Ordinance.

PROPOSAL B - ZONING - FULL REVISION OF PART 117

Shall the following amendment to the Milton Township Zoning Ordinance be

approved?

Amendment #2001-02 - A full revision of Part 117 of the Milton Township Ordinance, known as the "Milton Township Zoning Ordinance."

STAR TOWNSHIP Recall of Star Township Supervisor Arlen Turner and Clerk Marilyn Rypkowski

Recall wording, in separate ballot questions, indicates both Turner and Rypkowski should be recalled for his or her "failure to faithfully protect and represent the people of Star Township by doing the following: 1. Voted to let 'convicted felons' on the fire department. 2. Voted to start

a new fire department that will cost the taxpayer a very large increase in property taxes; 3. Voted to withhold taxpayer dollars designated by taxpayers for the Alba Fire Department."

Turner's response: "You elected me to represent Star Township as its supervisor, and to chair the township board. I have done this during my term of office with truthfulness and fairness to all township residents by keeping my thinking logical and making economically sound decisions for our entire township. I have studied the choices, and made my votes based upon factual, truthful infor-

mation, and careful study and thought about long-range plans for the benefit of many."

Rypkowski's response: "I was elected as Star Township Clerk over 25 years ago and feel I have performed my duties always with the Star Township residents' best interest. I am being recalled for a decision I made concerning the Alba Fire Board. This decision was made based on the true facts so that Star Township residents would continue to have fire protection and rescue services at no extra costs to the taxpayer."

BENZIE COUNTY

COUNTY PROPOSITION

Shall separate tax limitations be established for a period of four years, 2003-2006, inclusive or until altered by voters of the county, for the County of Benzie and the townships and intermediate school district within the county, the aggregate of which shall not exceed 6.77 mills as follows: County of Benzie, 5.29 mills; townships, 1.21 mills; intermediate school district, .27 mills
