BENZIE COUNTY PROPOSALS

Ambulance and Advanced Life Support Millage Proposal

Shall the tax limitation on general ad valorem taxes within the County of Benzie imposed under Article IX, Sec. 6 of the Michigan Constitution be increased for said County by .6500 mill (\$.65 per \$1,000 of taxable value) for a period of six (6) years, beginning Dec. 1, 2004, through 2009, inclusive, for the sole purpose of purchasing five (5) ambulances and equipment for and operating countywide ambulance and advanced life support services, and for paying any bond obligations incurred to finance the equipment purchases? If approved and levied in full, this millage will raise an estimated \$523.860.00 for the countywide ambulance and advanced life support services in the first calendar year of the levy based on taxable value.

Government Center Infrastructure Millage Proposal Shall the tax limitation on general ad valorem taxes within

the County of Benzie imposed under Article IX, Sec. 6 of the Michigan Constitution be increased for said County by 0.22 mill (\$.22 per \$1,000 of taxable value) for a period of ten (10) years, beginning Dec. 1, 2004 through 2013, inclusive, for the sole purpose of making necessary renovations and improvements for the Government Center building and for paying any bond obligations incurred to finance these renovations and improvements? If approved and levied in full, this millage will raise an estimated \$177,306.00 for the renovations and improvements for the Government Center building in increase tax limitations for prothe first calendar year of the levy based on taxable value.

Parks and Recreation **Program Millage Proposal**

Shall the tax limitation on general ad valorem taxes within the County of Benzie imposed under Article IX, Sec. 6 of the Michigan Constitution be increased for said County by

0.1000 mill (\$.10 per \$1,000 taxable value) for a period of four (4) years, beginning Dec. 1, 2004 through 2007, inclusive, for the sole purpose of operating and maintaining countywide parks and recreation facilities and a countywide parks and recreation program? If approved and levied in full, this millage will raise an estimated \$80,594.00 for the countywide parks and recreation program and facilities in the first calendar year of the levy based on taxable value.

TOWNSHIP PROPOSALS GILMORE

Renewal Proposition to viding the funds for upgrading roads in Gilmore Township Shall the 15 mill tax limitation on general ad valorem taxes within Gilmore Township imposed under Article IX, Sec. 6 of the Michigan Constitution be increased for said township by .45 mill (\$.45 per \$1,000 of tax- for four (4) years, 2004 through able value) for the period of

2004 and .45 mill per year for 2005, 2006, 2007, 2008 and 2009 inclusive for road upgrading and shall the township levy such an increase in millage for said purpose during such period which increase will raise in the first year of such levy an estimated \$10,951?

HOMESTEAD **Fire Department Millage Proposal**

This proposal will permit the township to restore the township's 1 mill for the general operation and maintenance of the fire department previously approved by the lectors and expiring in 2004. Shall the limitation on the amount of taxes which may be imposed on taxable property in the township of Homestead, County of Benzie, State of Michigan, be increased by up to one dollar (\$1.00) per thousand dollars (\$1,000) (1 mill) of taxable property in the township 2007 inclusive, for the purpose

of providing funds for the general operation and maintenance of the Homestead Twp. Fire Department? If approved and levied in its entirety, it is estimated that 1 mill would raise an estimated \$49,643 for the township when first levied in 2004.

PLATTE

Fire Millage Proposition

Shall the limitation on general ad valorem taxes which may be assessed against all property in Platte Township, Benzie County, be levied as provided by Section 6, Article IX of the Michigan Constitution of 1963 by one (1) mill of taxable valuation of all property in Platte Township (\$1.00 per \$1,000 taxable value) for a period of four (4) years, 2004 through 2007 inclusive, to be used for equipment and operation of the fire department within the township; and shall the township levy such millage for such purposes during such period, which will raise in the first year of such levy an estimated \$11,300?
