CRAWFORD COUNTY PROPOSALS

COUNTY E911 EMERGENCY SERVICE PROPOSAL

For the purppose of equipping, operating and maintaining E911 emergency service and central dispatch costs, shall there be a monthly assessment by the County of Crawford of no more than an additional 16 percent of the highest monthly flat rate charged by a elephone service fire department equipment supplier for the single party access line (not to exceed \$3.20) upon telephone service users within the Crawford County 911 service district for a period not to exceed four years, starting Oct. 1, 2004 and ending Sept. 30, 2008

COUNTY LIBRARY **OPERATING MILLAGE** PROPOSAL

Shall the limitation upon the total amount of general ad valorem taxes imposed upon real and tangible personal property for all purposes in any one year under the Michigan Constitution be increased in the County of Crawford, Michigan by 0.45 mill (which is equal to \$0.45 per \$1,000 of taxable value for all such property) for a period of 8 years, 2004 through 2011, inclusive, for the purpose of operating county library facilities located in the city of Grayling and the townships of Beaver Creek, Frederic and Lovells? The amount of revenue the county will collect if that millage is approved and levied by the county in the first calendar year is estimated to be \$219.768. The proposed millage is the authorization of new additional millage.

The \$43 annual posal of large items such as furniture, appliances, metal, etc. This fee will first appear on the December 2004 tax bills for refuse disposal during the calendar year of 2005, and will be repeated each successive year for a period of four consecutive years. This fee will raise approximately \$157,000 per year. All money raised from this fee will be used to opeate, maintain, repair and improve the **Grayling Township** Compactor/Recycling Center located at 4670 North Down River Road, Grayling.

This proposal will permit the Township to restore the Township's 1 mill for operating expenses that is fixed by law. which may be levied by the Township of Lovells, County of Crawford, Michigan, against Shall the previously voted taxable property in the Township be increased by .1155 dollars (\$.1155) per thousand dollars (\$1,000) (.1155 mill) of the taxable value on township for four (4) years, 2004 through 2007 inclusive, for the purpose of providing funds for operating expenses? If approved and levied in its entirety, it is estimated that the .1155 mill would raise an estimated \$4,867 for the township when first levied in 2004.

MAPLE FOREST

Frederic Township charges 2 mills for emergency services (fire and ambulance). Maple Forest Township will pay one mill of this charge from the Township Improvement Fund. Question:

Shall the Township of Maple Forest, located in Crawford County, Michigan, levy an ad valorem tax of 1 mill (\$1 per \$1,000 of taxable valuation) for a period of four years from 2004 through 2008 inclusive for the purpose of providing **Emergency Services** (fire and ambulance)?
