

KALKASKA COUNTY PROPOSALS

imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Excelsior Township, Kalkaska County, be renewed at one (1) mill (\$1.00 per \$1,000 of taxable value) for the period of 2004 through 2007 inclusive for the purpose of providing funds for operating and equipping a fire and rescue department for providing fire and rescue protection for said township; and shall the township levy such renewal in millage for said purpose, thereby raising in the first year an estimated \$34,400?

■ **Proposal B: Fire Equipment Millage Proposal** Shall the previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Excelsior Township, Kalkaska County, be renewed at up to seven-tenths mill (\$.70 for each \$1,000 of taxable value) for the period of 2004 through 2007 inclusive for the purpose of providing funds for the purchase of an ambulance, and other necessary equipment, for the township's joint fire and rescue department; and shall the township levy such renewal in millage for said purpose, thereby raising in the first year an estimated \$24,080?

**COLDSPRINGS**

■ **Proposal A: Fire and Rescue Protection Millage Proposal** Shall the previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Coldsprings Township be renewed at one (1) mill (\$1.00 per \$1,000 of taxable value) for the period of 2004 through 2007 inclusive, for the purpose of providing funds for operating and equipping a fire and rescue department for providing fire and rescue protection for said township; and shall the township levy such renewal in millage for said purpose, thereby raising in the first year an estimated

\$60,089.00?

■ **Proposal B: Fire Equipment Millage Proposal** Shall the previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Coldsprings Township be renewed at up to seven-tenths mill (\$.70 for each \$1,000 of taxable value) for the period of 2004 through 2007 inclusive for the purpose of providing funds for the purchase of an ambulance, and other necessary equipment, for the township's joint fire and rescue department; and shall the township levy such renewal in millage for said purpose, thereby raising in the first year an estimated \$42,063.00?

■ **Proposal C: Township Proposal for Garbage Pickup** Shall the previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Coldsprings Township be renewed at 1 ¼ mills (\$½5 per \$1,000 of taxable value) for the period of 2004 through 2007 inclusive for garbage pickup; and shall the township levy such renewal in millage for said purpose, thereby raising in the first year an estimated \$75,112.00?

**RAPID RIVER**

■ **Proposal A: Refuse Service Proposal** Shall the total tax roll limitation be assessed against all property in Rapid River Township, Kalkaska County, be set at 1.5 mill on each dollar (\$1.50 per \$1,000 of taxable value of all property in said township) annually for a period of four (4) years (2004, 2005, 2006, and 2007) for the purpose of providing funds to continue the operation of a household refuse collection service for Rapid River Township, and shall Rapid River Township levy such millage for such purpose during such period, which will raise in the first year of such levy an estimated \$62,365.00?

■ **Proposal B: Annual Clean-Up Service Proposal** Shall the total tax roll limitation be assessed against all property in Rapid River Township, Kalkaska County, be set at .5 mill on each dollar (\$.50 per \$1,000 of taxable value of all property in said township) annually for a period of four (4) years (2004, 2005, 2006, and 2007) for the purpose of providing funds to continue the operation of the bi-annual township clean-up service for Rapid River Township, and shall Rapid River Township levy such millage for such purpose during such period, which will raise in the first year of such levy an estimated \$20,788.00?

■ **Proposal C: Road Construction Proposal I** Shall the total tax roll limitation be assessed against all property in Rapid River Township, Kalkaska County, be set at one (1) mill on each dollar (\$1.00 on each \$1,000 of taxable value of all property in said township) annually for a period of four (4) years (2004, 2005, 2006, and 2007) for the purpose of providing funds to continue local Rapid River Township roads, and shall Rapid River Township levy such millage for such purpose during such period, which will raise in the first year of such levy an estimated \$41,577.00?

■ **Proposal D: Road Construction Proposal II** Shall the total tax roll limitation be assessed against all property in Rapid River Township, Kalkaska County, be set at one (1) mill on each dollar (\$1.00 on each \$1,000 of taxable value of all property in said township) annually for a period of four (4) years (2004, 2005, 2006, and 2007) for the purpose of providing funds to continue local Rapid River Township roads, and shall Rapid River Township levy such millage for such purpose during such period, which will raise in the first year of such levy an estimated \$41,577.00?
