■ County Proposition 1 Animal control operating millage Shall the County of Manistee authorize and increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within the County of Manistee at .2000 mill (\$0.20 per \$1,000 of taxable value) for the five (5) year period of 2004 through 2008, inclu-

sive, for operational and building maintenance costs at the Manistee County Animal Control Facility, and shall the County of Manistee levy such increase in millage for said purpose, thereby raising in the first Constitution of the State of year an estimated \$167,754.

■ County Dial-A-Ride Shall Manistee County increase the constitutional limitation on the total amount of general ad valorem taxes imposed on all real and personal property in Manistee County as provided for in Article IX, Sec. 6, of the Michigan of 1963, for all purposes by 0.3300 mill (\$.33 per \$1,000 of taxable valuation) and levy .3300 mill for six years (2004 through 2009 inclusive)

■ County Council on Aging Millage Renewal Shall the County of Manistee renew a previous voted

increase in the tax limitation imposed under Article IX, Sec. 6, of the Michigan Constitution on general ad valorem taxes imposed upon real and tangible property within the county of Manistee for a period of six (6) years, 2004, 2005, 2006, 2007, 2008 and 2009, inclusive, by up to .30 mill (\$.30 per \$1,000 of taxable value), to be used for the supp-


