■ County Proposal Older citizens services renewal millage proposal

Shall the previously voted increase in the tax limitation on general ad valorem taxes within the County of Wexford imposed under Article IX, Section 6 of the Michigan Constitution be renewed at 0.4000 mill (\$0.4000 per \$1,000 of taxable value) for a period of four (4) years, 2005 through 2008, inclusive, for the sole purpose of providing operating millage for the funding of older citizen services within Wexford County. (If approved and levied in full, this millage will raise an estimated \$318,403.00 for the countywide older citizen services in the first calendar year of the levy

based on taxable value).

■ Shall the Township of Boon, Wexford County, State of Michigan, levy an additional .0973 (\$0.973 per \$1,000.00 of taxable value) on all real and personal property within the township of Boon for a two-

■ Shall the Township of Boon, Wexford County, State of Michigan, be authorized to renew .9702 mill (\$.9702 per \$1,000.00 of taxable value) plus

an additional millage of .0298 (\$.0298 per \$1,000.00 of taxable value) for a total of 1.00 mill (\$1.00 per \$1,000.00 value) upon real personal property within the Township of Boon for levy in the years 2004, 2005, for the purpose to provide fire protection by the Boon Volunteer Fire Department, which would levy the sum of


