Ex-reserve cop sentenced

TRAVERSE CITY — A former reserve officer was sentenced to prison Friday for a Christmas-night standoff with **Grand Traverse County** Sheriff's deputies.

Jon W. Grist, 38, was sentenced to 1½ to four years in prison for assault with a dangerous weapon. Following a domestic dispute Christmas night, he pointed a gun toward two family members and Sheriff Scott Fewins and fired the weapon several times into the woods near his Blair Township home.

Grist's addiction to prescription drugs, alcohol use and other personal problems played a significant role in the incident, his attorney said. Grist is a former reserve officer with the Grand Traverse County Sheriff's Department.

United Way cuts funding TRAVERSE CITY — After a 54-year partnership, United Way of Northwestern Michigan has terminated next year's funding for The Salvation Army in Leelanau and Grand Traverse counties.

Major Thomas Riggs of The Salvation Army said his group received \$25,000 from United Way this year to provide emergency assistance to 7,800 people.

Its annual operating budget is \$500,000.

"It is a blow, definitely, and a surprise of equal proportion," Riggs said. "We had no prior warning that this was something that might even happen."

Riggs, who took over the commanding officer post six months ago, said The Salvation Army complied with the application process and submitted a wellresearched request.

Becky Beauchamp, executive director of the United Way of Northwest Michigan, said the group's long-standing relationship with the United Way does not entitle it to funding.
