named Grand Traverse and Saginaw bays as two pilot areas for a special review that was allowed in an amendment to a new state law passed last month.

Though a state permit is not needed, lakefront owners in the two areas must still ask written permission from the DEQ before removing shoreline vegetation. And a federal permit from the U.S. Army Corps of Engineers remains a requirement.

#### **JUNE 26**

Sugar Loaf owner jailed DETROIT — Sugar Loaf Resort owner Remo Polselli was sentenced Wednesday in federal court to 27 months in prison and must pay \$2.9 million in restitution on tax charges involving a Southfield hotel.

Polselli, 47, of Bloomfield Township, had pleaded guilty on Jan. 9 to one count of failing to account for and pay withholding and Social Security taxes and two counts of failing to file federal income tax returns for the years 1995 and 1996.

According to his indictment, Polselli had owned and operated the Plaza Hotel in Southfield through **Prudential Management** Corp. and Infinity Group Ltd. from 1993 to 1997.

During that time, the hotel deducted and collected more than \$2.4 million in federal income and Social Security taxes from employee wages but failed to pay the withholdings to the Internal **Revenue Service.** 

In addition, Polselli failed to file personal income tax returns after grossing \$602,000 in 1995 and \$697,000 in 1996.

#### **JUNE 27**

Judge sentences man TRAVERSE CITY — After

more than two years on the run in Florida, Harry J. Dobek III, 27, was captured and returned to Michigan to face the charge of firstdegree criminal sexual conduct.

But prosecutors determined the credibility of the witness against Dobek was questionable and he was offered a plea to misdemeanor assault.

On Thursday (June 26), District Judge Thomas J. Phillips sentenced Dobek to a year in jail, the maximum penalty allowed.

Dobek's attorney, Wilson Brott, said the witness against Dobek admitted to police that she had trouble telling the truth.

Dobek also faces possible prison time for violating his probation.

A former reptile salesman, he was convicted of felony theft after he stole an estimated \$1,200 worth of lizards, exotic turtles and poisonous snakes from another reptile dealer.

Cherry board eyes diversion TRAVERSE CITY - Local

cherry growers doubt an industry forecast of surplus crop and some oppose a proposal to set aside 15 percent of their cherries.

The Cherry Industry Administrative Board on Thursday called for 15 percent of Michigan's crop this year to be set aside or "diverted."

That means they can either be sold overseas, stored by processors in case of a short crop in the future, used for new products or left on orchard grounds to rot.

The board estimates 150 million pounds of tart cherries harvested in Michigan this year, out of a total 218 million pounds in the entire United States.

#### **Stupak: Saving land tops**

**GRAYLING** — Opposition to a plan to drill under a prized portion of the Huron **Manistee National Forest** near the AuSable River is mounting, as U.S. Congressman Bart Stupak is calling on the state to carefully evaluate the proposal and a sportsman's group is considering creative measures to thwart the idea.

Savoy Energy of Traverse City wants to slant drill an exploratory well in the Huron Manistee National Forest adjacent to the Mason Tract.

The tract, 1,200 acres and 14 miles of AuSable River, were given to the state to remain undeveloped by auto executive George Mason upon his death in 1954

Stupak, D-Menominee, is urging Department of Environmental Quality officials to exercise all of its authority under oil and gas regulations when considering the drill-permit request.
