### Board to consider raises

GREILICKVILLE — The Elmwood Township Board will consider a budget tonight that includes pay raises for elected and appointed officials.

Supervisor Noel Flohe said the board proposed the increases, ranging from 4 percent to 33 percent, to get salaries in line with those paid in other townships.

The board looked at salaries paid to officials in other townships, including Garfield and Long Lake, Flohe said. After seeing a wage discrepancy they decided some officials in Elmwood deserved more than a standard 2 or 3 percent increase.

**Prosecutor wants kids out** BEULAH — Authorities investigating the weekend death of an Oakland County woman near Herring Lake hope to remove her children from their father's custody.

Benzie County Prosecutor Anthony Cicchelli said Monday he planned to file a petition with the state Family Independence Agency to remove Florence Unger's two pre-teen children from her husband, Mark's, custody.

The official cause of death of Florence Unger, 37, of Huntington Woods, is pending, Benzie County Medical Examiner Matthew Houghton said.

Houghton said forensic pathologists at Spectrum Health in Grand Rapids are attempting to determine whether Unger drowned or died from a head wound.

**TCAPS says no to laptops** TRAVERSE CITY — A state program to give all sixthgrade students a laptop computer could cost the Traverse City district \$5.2 million over seven years, school officials say.

Traverse City Area Public Schools will pass on the gift, which it says comes with some very pricey strings attached.

Superintendent James Pavelka said the calculations, worked out by the district's financial officer, helps schools determine if they can afford to accept the state's offer to spend \$250 per student on wireless computer devices.

The state Legislature and Gov. Jennifer Granholm in August approved \$22 million in state funds and \$17 million in federal funds to pay for the program. That amount, plus a \$25 per-student contribution from the district, would give a laptop to each of the state's 132,000 sixth-graders.

**Law agencies to relocate** TRAVERSE CITY — The Traverse City Police Department and Grand Traverse Sheriff's Department will move their headquarters to a new location on Friday.

While some delays in administrative business are expected Friday through Monday, officials said law enforcement functions will operate without interruption.

The new address for the law enforcement center beginning Nov. 3 is 851 Woodmere Ave. The Grand Traverse County Jail will remain at its current location.

**Fair ban decision stalled** CHEBOYGAN — A state administrative law judge will wait till next year before deciding whether to lift an order that permanently blocks the Cheboygan County Fair from sponsoring any more Toughman contests.

At a hearing Wednesday, Renee A. Ozburn, a law judge with the Department of Consumer and Industry Services, requested attorneys in the case to submit written briefs to her by Jan. 30.
